**INFORMATION ON THE PROCESSING OF PERSONAL DATA**

In compliance with the contents of Article 13 of the (Italian) Legislative Decree No. 196/2003 (the Code on the subject of the protection of personal data), we wish to inform you that the personal and corporate information that you supplied us with and which was drawn up in the Exhibition's application form and in other, relative forms, or rather, acquired in some other way within the ambit of the activities conducted by Fiera di Vicenza S.p.A. itself, shall be subject to processing, in compliance with the duties of confidentiality and in compliance with that which has been explicitly established by the aforementioned Code. The processing of these personal data, which shall be dealt with by means of information technology or manual instrumentation, shall be kept for the following purposes:

- a) Communications and commercial promotions concerning the activities of Fiera di Vicenza S.p.A.;
- b) Statistical processing and auditing activities;
- c) Analysis and market research;
- d) Historical information archiving.

The processing of personal data implies: their collection, registration, organisation, conservation, processing, amendment, selection, extraction, comparison and re-classification of information into uniform economic categories, use, inter-connection, blockage, communication, diffusion and inclusion into the official Internet site of Fiera di Vicenza S.p.A. of the data relative to information of a commercial nature, cancellation or combination of two or more of the aforementioned operations. The personal data may be sent to the attention of: companies which, on behalf of Fiera di Vicenza S.p.A., supply information technology assistance and consulting services, to the employees of Fiera di Vicenza S.p.A., who have not been specifically indicated, in compliance with Article 30 of the aforementioned Code, to Public Authorities or Institutions, to companies which have been entrusted with tenders, on behalf of Fiera di Vicenza S.p.A. Conferral of the personal data to the attention of Fiera di Vicenza S.p.A. is only necessary in the case of information that is foreseen as being a legislative or contractual obligation, as well as for allowing the performance of that which has been requested by the party conferring the personal data. Any refusal to grant the data concerning the carrying out of activities different from those inherent in performing the contractual relations or any requests forwarded, may lead to said other activities being hindered, but shall not interfere in conducting the contractual relationship in course. We would also like to inform you that Article 7 of the aforementioned Code, acknowledges the party concerned with numerous rights, amongst which: access to the Ombudsman's registers, to obtain information with reference to the data concerning him and to obtain the cancellation of or the blockage, or rather, the updating, adjustment or integration, as well as the certification that said operations have been brought to the attention of those to whom the data were communicated, to oppose, for lawful reasons, the processing of said data and oppose the processing for commercial or advertising purposes or market research.
